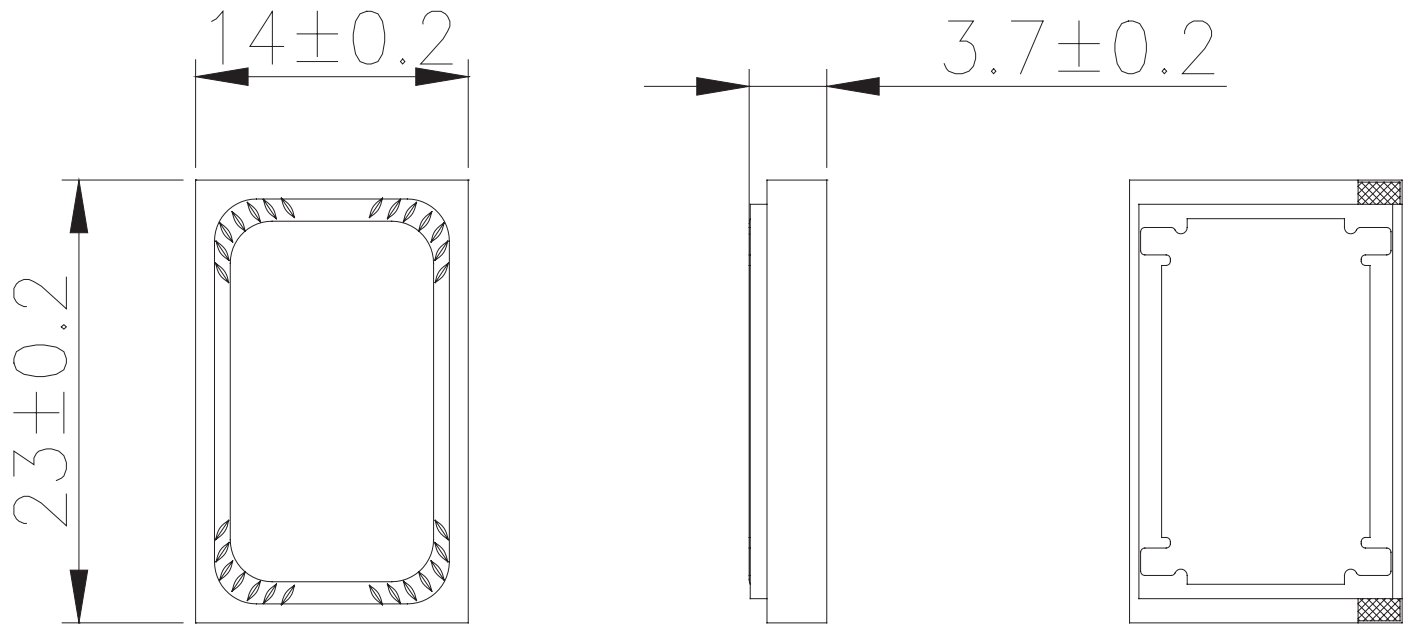

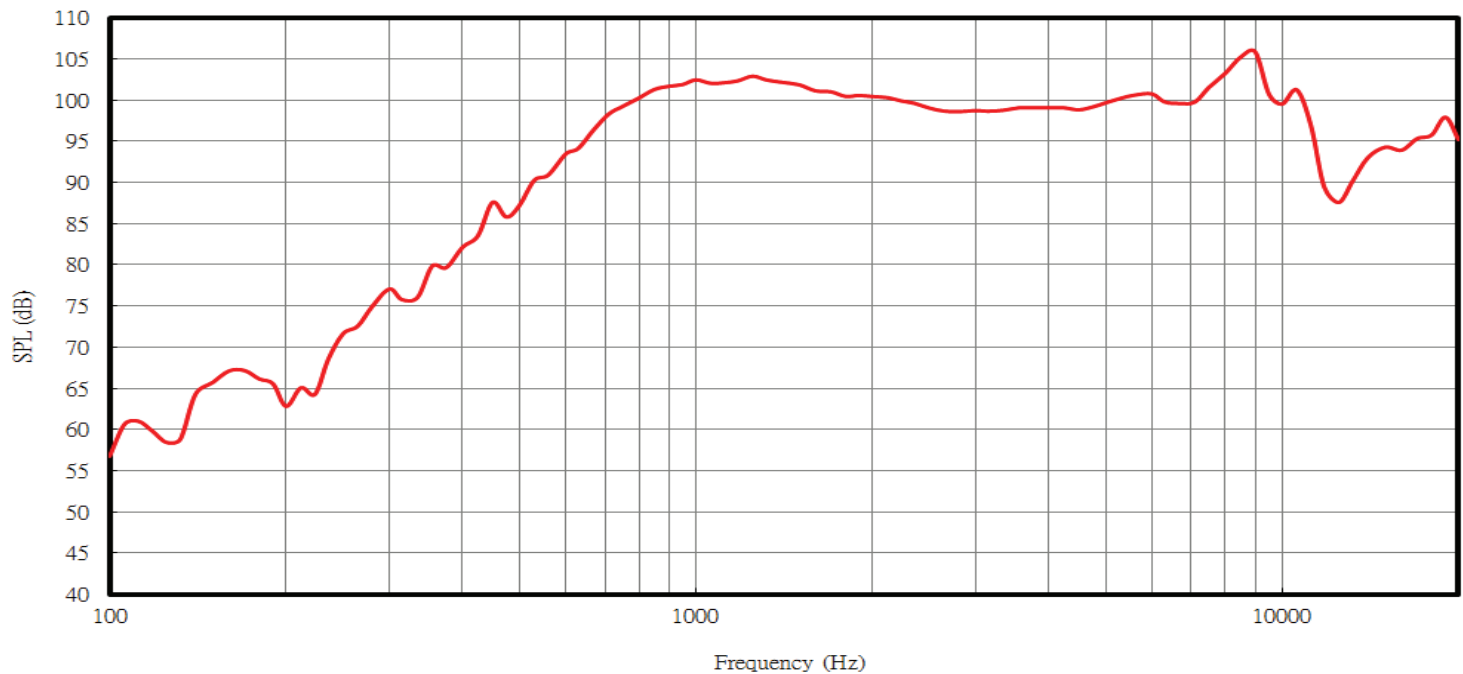

## RESPONSE CURVES

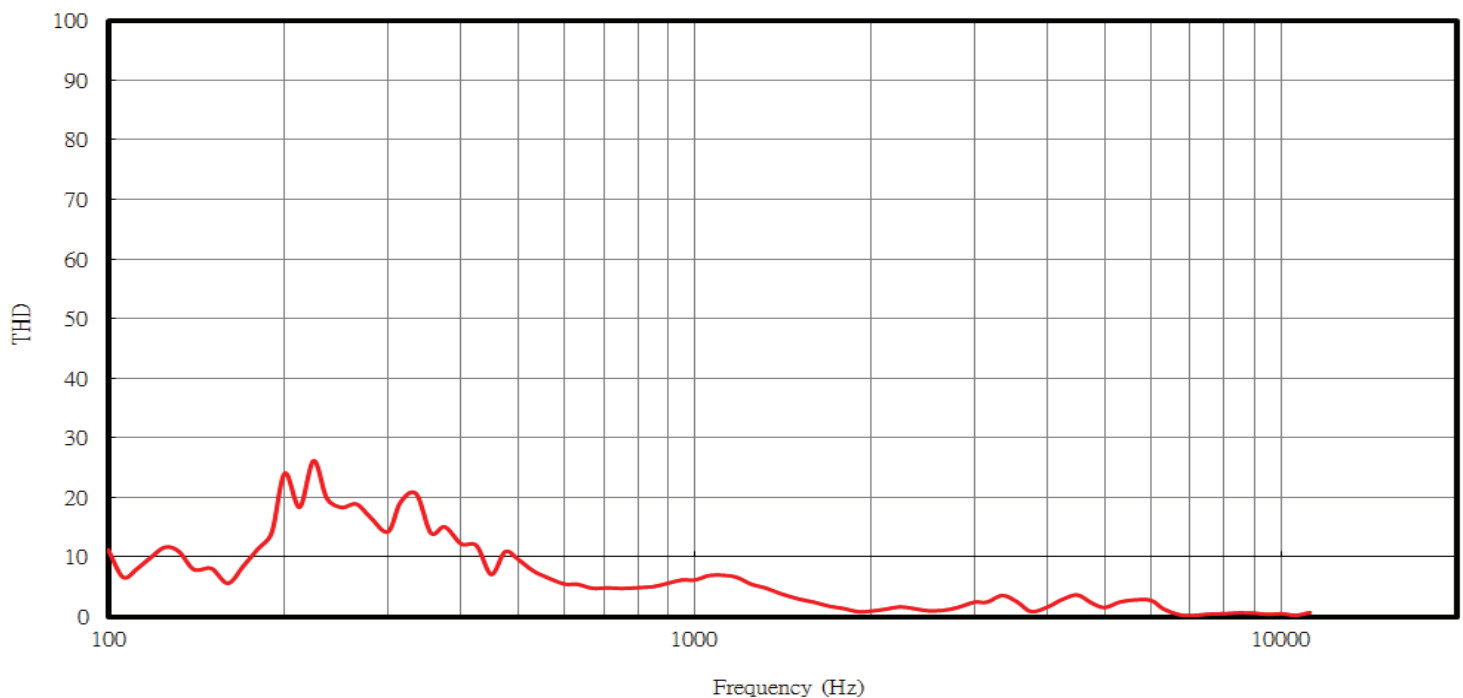
### Frequency Response Curve

### Total Harmonic Distortion Curve

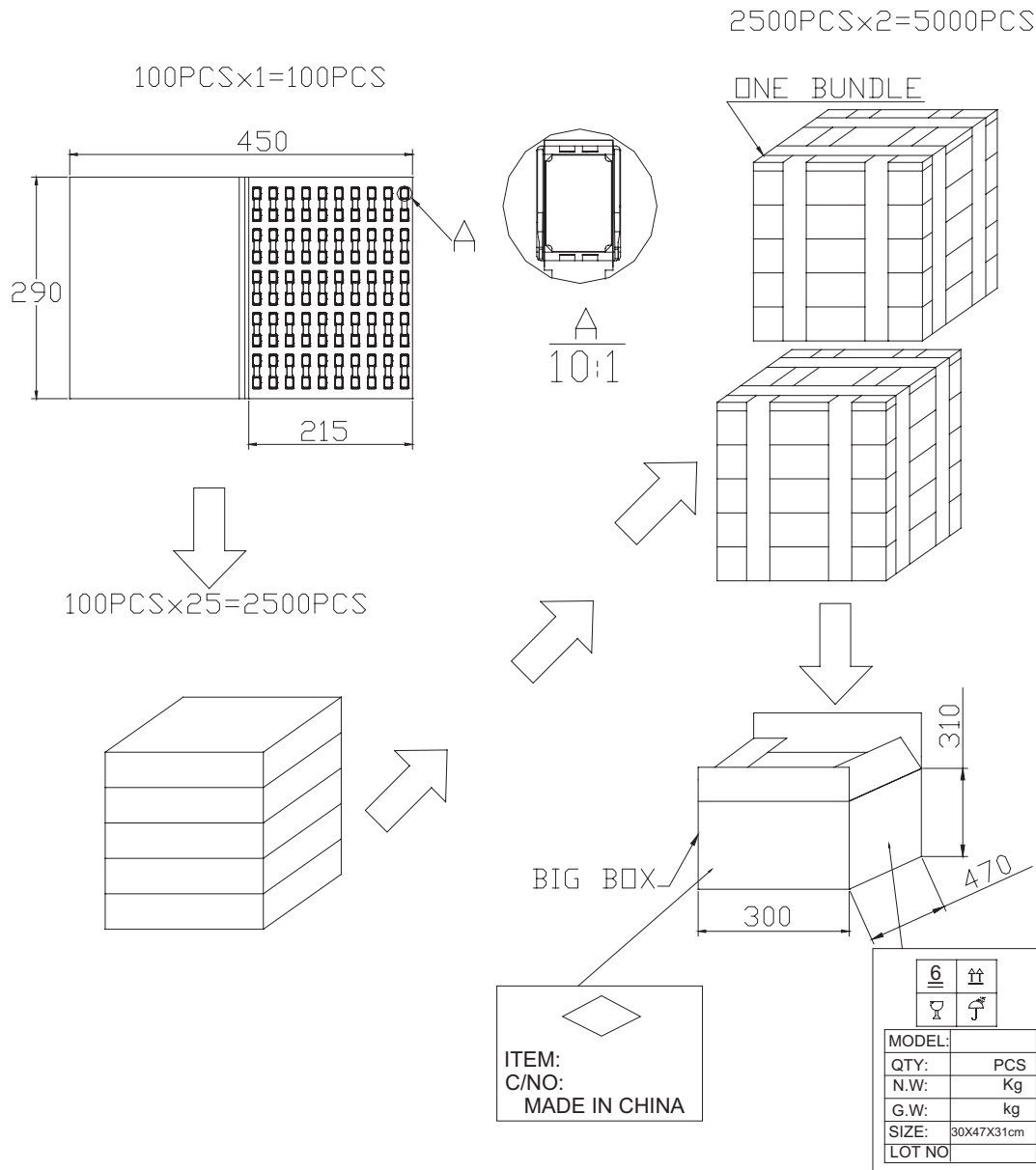
