General	<p>When connecting the signal lines to the black PCB terminal blocks, please use a 0.4 x 2.0 mm screwdriver.</p> <p>The black PCB terminal blocks only require a minimal amount of operating force.</p> <p>Screwdriver: SZS 0,4X2,0 - 1205202</p> <p>Using larger screwdrivers or excessive force may damage the PCB terminal blocks.</p> <p>When using ferrules, the wires can be inserted straight into the PCB terminal blocks without opening the clamping area.</p>



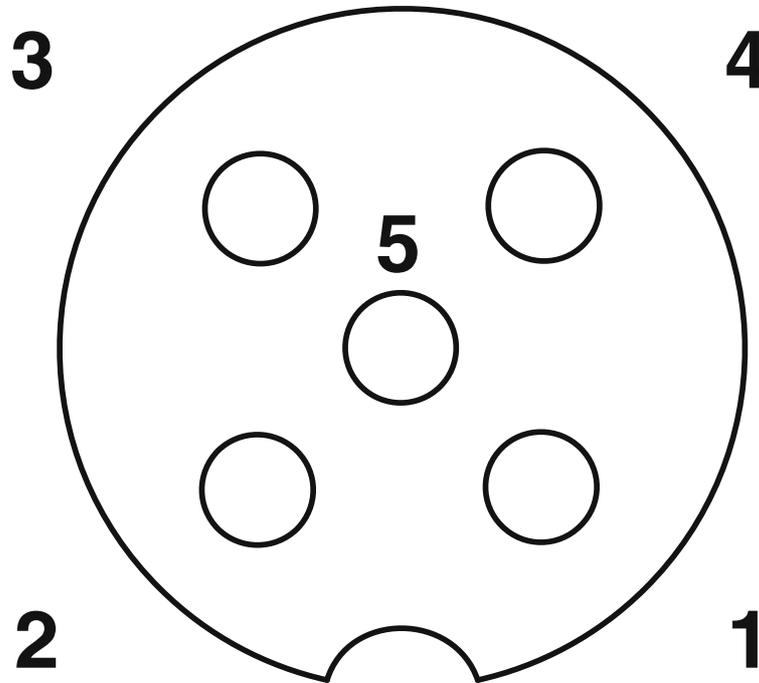


